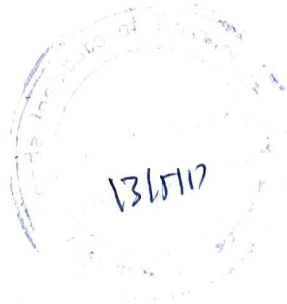

You are selected for the post of App ALP (Dsl / Elec) on a stipend of Rs.7730/-p.m. by RRB / SC and accordingly you are hereby offered the said post in TRSO [Running] Department on Vijayawada Division, S C Railway.

This offer is subject to the following Conditions:--

1. You will have to pass the prescribed Medical Examination viz., A-One, before your engagement. If you fail in the medical test, you will not be engaged.
2. If you are in Govt./Quasi Govt. Service, you have to bring a certificate to the effect that you will sever connections with your employer only after completion of all formalities for engagement and successful completion of the medical examination.
3. You will be under training on Stipend of Rs.7730+ usual allowances, normally for a period of 153 [One hundred and fifty three] days [which can be curtailed or extended by the administration], and if there is any adverse report during the period of training such as being found guilty of insubordination, misconduct, disobedience and / or disregard of departmental rules, or absence without prior sanction of leave or proper Railway Medical Certificate etc., your apprenticeship is liable to be terminated. At the end of the prescribed training, you will have to appear for the Final Examination and pass the same at the first attempt. There will also be departmental test at the end of certain items of training. If you are not considered fit for retention as a result of any of these examinations, you are liable to be discharged from service and liable to be posted back to your post in case you are already a serving employee in Railway.
4. You should execute an Indemnity Bond duly affixing Special Adhesive Stamp [not less than Rs.20/-] with an Agreement to serve as Apprentice for 39 Weeks in a form prescribed by the Administration (Proforma enclosed) before joining training, binding yourself and your SURETY to refund the cost of the training and all money paid to you, in the event of your failing to satisfy the conditions stipulated above. This security will be liable for forfeiture by the Railway Administration in the event of failure on your part to complete the training or fulfill any of the terms of the aforesaid Agreement. The value of the stamp to be affixed on the Agreement should also be borne by you.
5. No guarantee or promise of employment will be given but on satisfactory completion of your training as Apprentice ALP [DSL / ELEC] , you will be eligible for appointment as Asst Loco Pilot [Dsl/Elec] in scale Rs.5200-20200+1900 G.P., subject to availability of a vacancy. 
